1. President's Report

Hi everyone and welcome to our end of winter newsletter. Hope you have all survived the cold snaps and perhaps done a few laps in an indoor pool.

Of course, our beloved outdoor Manuka Pool closed for the season on Sunday 24 Mar 2024 with a magnificent finishing event – the 24-hour fundraising event for Laps for Life.

Laps for Life wrap up

This year we had over 150 swimmers powering out laps every hour from 2pm on Saturday 23 Mar to 2pm on Sunday 24 Mar with over 11,000 laps in total. We also had 20 regular swimmers registered for laps throughout March with many raising hundreds of dollars individually for the Manuka Pool Lappers Team.

Thanks to Bryan Pasfield and his family of helpers who coordinated this event and managed to raise \$19,000. We also made it on to the WIN News on the Monday evening!

Saga of the Canberra Services Club request for DA variation on previous club site

Over the autumn and winter, FoMP and other community groups have been waiting for the outcome of our responses to the DA variation of the lease for a site adjacent to the pool by Canberra Services Club. The Club wrote to us and others about having one-on-one meetings to convince us of the merits of the deconcessionalisation. Not one group wished to do this but requested a public meeting instead, which has not been forthcoming. Given the upcoming election, we believe nothing much will happen now until next year.

Club Champion's Board

We have made progress with obtaining the 'lost' Champion's Board in that the Canberra Amateur Swimming Club has agreed to a permanent loan of the Board at Manuka Pool. We are now waiting for a formal loan agreement to be arranged, seeking heritage advice on how best to conserve the board and an affirmative from the ACT government to pay for the lockable box with glass and a plaque. These things seem to take a long time, but we are hoping to have the project completed by the beginning of the pool season in late October. Fingers crossed!

Heritage Walk and Talk

Our third annual walk and talk at Manuka Pool took place on Saturday 20 Apr 2024 during the ACT Heritage Festival.

David Hobbes, a retired Canberra heritage architect, once again regaled an eager group of 18 people with a detailed history of the architecture of the building and interesting stories of the beginnings of what was then 'The Swimming Pool'.

Some attendees provided their own memories of their childhood at the pool and were delighted to revisit the changerooms, the toddler pool and, for some, reminiscing about the old diving board!



6. The Mystery of the Missing Lamp Post

After the heritage walk at Manuka Pool in April, eagle-eyed FoMP members identified that one of the heritage-listed lamppost shades had been replaced with a new LED one.

Why this happened remains yet another mystery and enigma of the operations of the ACT Government. Manuka Pool has a Conservation Management Plan that cites what can and cannot be done by anyone operating within the precinct, the ACT Property Group knows this, our amazing pool manager Bryan knows this, ACT Heritage knows this, but apparently Transport Canberra and City Services does not know this!

After FoMP contacted Minister Vassarotti and ACT Property Group, a similar but not identical heritage shade was found and installed. ACT Property Group continues to work with TCCS to try and locate the original shade. In the meantime, we understand the replacement shade will be painted Brunswick green to match the heritage colours of the site.

7. Upgrades to roads around Telopea Park school

Many of us have experienced the chaos and near accidents round school drop-off and pick-up times at the crossing and intersections near Telopea Park School.

Several weeks ago, Rebecca Scouller wrote to the Minister for City Services, Tara Cheyne MLA, regarding the proposed upgrades to roads and traffic around Telopea Park and Kingston that had been mentioned in the Canberra Times. Rebecca received a reply on 20 Aug 24 with the main points being:

Transport Canberra and City Services (TCCS) will be installing three wombat pedestrian crossings (raised zebra crossings) on routes to Telopea Park School within coming months. These crossings will help to manage vehicle speed and give priority to active travel.

The crossings will be installed on Telopea Park and New South Wales Crescent at the intersection with Currie Crescent, and on New South Wales Crescent at its intersection with Telopea Park.

Full detailed plans are 7 pages long and are available on request from FoMP.

- Engaging government and key stakeholders in relation to the upgrading or the establishment of key aquatic infrastructure; and
- Leveraging new and existing partnerships with key industry stakeholders to promote aquatic sports within the ACT and its surrounding regions.

Another pool in distress –Phillip

Earlier this year, a group led by Sarah Ransom contacted us to find out how FoMP managed to save Manuka Pool from the developers. Rebecca Scouller has been in regular contact with the group and suggested forming a Canberra pool alliance. Unfortunately, this did not get off the ground with other pool advocates, so the Phillip group are going it alone. However, we are still in contact, and this is Sarah's latest email to FoMP committee:

Save Phillip Pool started as a Facebook group early in 2024 as an effort of a group of local swimmers wanting to demonstrate that our local pool is loved and wanted.

Building on years of advocacy by the Woden Valley Community Council and others, the crunch point came when in late 2023, after years being closed, it was announced that Geocon had bought the lease to the pool.

While current lease conditions require a pool to be operated on the site, at some point shortly before the sale this requirement was changed from a 50m outdoor pool and ice rink to a 25m indoor pool due to "changing community preferences". We don't agree! Phillip Pool has become run down, with no public sign, and is so surrounded by overgrown bushes that many Woden residents don't even know it's there. Despite this, it is clean and cool and absolutely the best spot Southside for 50m laps as the water glitters in the early morning sun.

With a little political will and imagination, and investment, Phillip Pool could be a real community drawcard once again. The omens are not good with the pool now owned by a developer, but this is not beyond the government's ability to solve. Hundreds of us are looking for that in the upcoming ACT election....

11. Condolences card eulogy

Sent to David Denham's son, Angus, and to GNCA committee.

David and many others, as part of the ISCCC and as individual groups, have worked on many significant issues over the years, including planning and legislative reform. However, I would say the biggest project we all worked on together was in 2016, saving the Manuka Oval Precinct from an unsolicited bid from Greater Western Sydney and Grocon.

The proposal included up to 1000 apartments around the oval, the loss of the heritage listed Manuka Arts Precinct, and 1500m2 of the Manuka pool lawns and a land swap deal that would have most likely seen the closure of MOCCA childcare centre,

a community childcare centre more than 40 years history, and the Telopea Park School tennis courts. There were also rumours of the loss of Montgomery Oval, and exclusive use of Manuka pool and Telopea Park for GWS training.

In opposition, several community groups formed a coalition to fight the proposal. The campaign against the bid took hundreds of hours of community members time, more than 300 people turned up to a community meeting and we collected around 500 signatures across a single weekend, opposing the development.

It took seven months of sustained campaigning, media, meetings, FOI requests and analysis before the Chief Minister went from being 'impressed' with the proposal – to rejecting it. It was also an election year which may or may not have worked in our favour.

It was the tireless efforts of people like David who helped convince Canberra that we were not a bunch of NIMBYs but, in fact, the proposal was a had deal for Canberra rategages, pearly public land

the proposal was a bad deal for Canberra, ratepayers, nearby public land and assets and for the oval itself.

With hundreds of pages of material to read and analyse, it was always great to know that David was there to assist with the analysis and synthesis of material so that we could present cohesive and compelling arguments to the media and the community. Without people like David, our local areas could potentially be very different to what we know and love today.

David's efforts supporting issues within Griffith and Narrabundah and the greater Canberra region to ensure Canberra is an equitable and sustainable place to live is recognised by the many who know what is involved in maintaining the rage. And while some may still call us NIMBYs and some may never realise the huge efforts of people like David, his legacy will remain for many decades to come.
